The Merrimack School District has established a Curriculum, Instruction, Technology Integration Technology Systems, Assessment, and Data Committee (District CIT)

## Topics that are addressed by the CIT include:

- Review of issues related to curriculum development to be referred to or from curriculum review committees, a collaboration, e.g. changes in state or content area standards and local efforts to align with these changes with minimal disruption.
- Selection of systems, materials, and technology to streamline and support the universally designed delivery of instruction, ensuring equitable access to all curricula.
- Review of course offerings district-wide, including distinctive pathways designed to ensure that each student's particular educational needs and capabilities are served.
- Differentiation activities, including enrichment and delivery of a rich and appropriately challenging
  program to typical students, and efforts to meet special education and English-language needs when
  appropriate.
- Development of review criteria for the evaluation of supplementary tools such as technology tools,
   websites, audiovisual materials, or other instructional supports identified by educators.
- Provide systems and support for the review of data and assessments used to guide educational decisions and provide reports on student progress to a variety of audiences.

- Promote reflection and inquiry that supports student learning and continuous improvement.
- Foster a Pre-k-12 perspective.
- Support a vision of academic growth and achievement toward high academic standards.
- Support engagement and communication with the broad educational community (e.g. teachers, school personnel, parents, administrators, community members, and students).
- Acknowledge the expertise and perspective of all participants (teachers, school personnel, parents, administrators, community members, and students).
- Build upon the role played by schools and departments as key contributors to the curriculum review process.
- Create an intersection of curriculum, instruction, assessment, communication, and technology

## The Committee Will:

- Work as a team with administrators, educators, board members, parents, and students.
- Review the analysis and discussions from the school level, then expand to district wide analysis and discussion.
- Collect and analyze relevant data as needed to evaluate the effectiveness of our program.
- Determine the strategic goals and criteria to be used in making final recommendations and decision.
- Identify a range of possible actions or changes which could help to improve programs and instruction.
- Collect representative input from administrators, teachers, parents, and students.
- Develop a yearly district report card that will be communicated to the greater Merrimack Community.
- Communicate with District Leadership and Merrimack School Board.
